RESOLUTION NO. 68 s. 2016

**A RESOLUTION REQUIRING ALL THE ACCREDITED 2016 CIVIL
SOCIETY ORGANIZATIONS FOR THE REPRESENTATION TO THE
LOCAL SPECIAL BODIES TO SUBMIT THE NAMES OF THEIR
RESPECTIVE PRINCIPAL AND ALTERNATE REPRESENTATIVES
TO THE LOCAL SPECIAL BODIES**

WHEREAS, DILG Memo Circular #2016-97, article VIII number 5, dated 20 July 2016, states that the “executive officers, or the duly authorized representatives of the selected CSOs shall designate their principal and alternate representatives to the local special bodies where they are to sit as members;

WHEREAS, To avoid misrepresentation during the meeting for the selection of CSO Representatives for the special boards and in compliance to the DILG Circular, it is but proper for all accredited CSOs to provide the names of their organization's official representatives to the selection meeting before its scheduled assembly;

WHEREAS, During the Committee on Rules, Resolutions, Ordinances and Accreditation Hearing, dated 24 August 2016, the 65 attendees and members of different CSOs agreed to provide the names of their representatives to the Sangguniang Bayan before their Accreditation certificates are released to their organizations;

WHEREAS, The documents identifying the names of their primary and alternate representative be submitted to the August Body in a form of a board resolution of their organization;

WHEREAS, The agreed deadline by all of the attendees to submit the names of their representatives for the selection was set on 31 August 2016 and a final list of accredited CSOs and duly recognized representatives be published by the Sangguniang Bayan;
