**RECOMMENDING TO THE LOCAL CHIEF EXECUTIVE HON. GEORGE
RICARDO R. GACULA II TO GRANT FINANCIAL ASSISTANCE TO THE
RESIDENT OF BLOCK 28, EXODUS FLOODWAY, BRGY. STA. ANA, TAYTAY,
RIZAL WHOSE HOUSES WERE AFFECTED BY THE FIRE THAT OCCURRED
LAST JULY 16, 2016 AT 7:00 PM IN THE SAID AREA**

WHEREAS, last July 16, 2016 at 7:00 pm, a fire broke out at Block 28, Exodus Floodway, Barangay Sta. Ana in this municipality;

WHEREAS, the said disaster had left an estimated seven (7) families who suffered from injuries and loss of properties;

WHEREAS, portion of Section 447 RA 7160, otherwise known as the Local Government Code of 1991 states that one of the functions of the Sangguniang Bayan is to “adopt measures to protect the inhabitants of the municipality from the harmful effects of man-made or natural disaster and calamities and to provide relief services and assistance for victims during and aftermath of said disaster or calamities and their return to productive livelihood following said events”;

WHEREAS, it is imperative that the victims of the said disaster be granted financial assistance, for them to be able to meet both ends and probably start a normal life;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan duly assembled in session hereby recommend to the Local Chief Executive Hon. George Ricardo R. Gacula II to Grant Financial Assistance to the Residents of Block 28 Exodus Floodway, Barangay Sta. Ana, Taytay Rizal whose houses were affected by the fire that occurred last July 16, 2016 in the said area;

RESOLVED FURTHER, that copy of this resolution be furnished to all concerned for their information and appropriate action;

ADOPTED, this 21st day of July 2016 at the Session Hall of the Municipal Building, Taytay, Rizal.
