**RESOLUTION NO. 91 s. 2016**

**A RESOLUTION REQUESTING THE SANGGUNIANG PANLALAWIGAN  
OF RIZAL TO ENACT AN ORDINANCE COMPELLING ALL MUNICIPALITIES  
AND CITY WITHIN THE PROVINCE TO RECOGNIZE ALL VALID TRICYCLE  
FRANCHISE, FROM THE POINT OF ORIGIN, AND BE NOT APPREHENDED  
AS “OUT OF LINE” WHILE TRAVERSING TO OTHER PLACES WITHIN THE  
PROVINCE OF RIZAL**

WHEREAS, it’s been a perennial problem in our local transport sector the continuous apprehension of tricycles coming from other town due to “Out of Line” violations;

WHEREAS, Sec. 447 (3), (VI), and Sec 458 (3), (VI) of RA 7160 Local Government Code of 1991, empowers the Municipalities and Cities, respectively to regulate and grant tricycle franchises within their territorial jurisdiction;

WHEREAS, valid tricycle franchise from their point of origin is not being recognize in other towns;

WHEREAS, this humble request to the Sangguniang Panlalawigan to pass a measure will address the said perennial problem;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 10<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, duly assembled in session hereby request the Sangguniang Panlalawigan of Rizal to enact an ordinance compelling all Municipalities and City within the Province of Rizal to recognize all valid tricycle franchise from the point of origin, and be not apprehended as “out of line” while traversing other places within the Province of Rizal.

RESOLVED FURTHER, that the copies of this resolution be furnished to all concerned for their information and appropriate action.
