MEMORANDUM OF AGREEMENT WITH SM PRIME HOLDINGS, INC.
REPRESENTED BY SM LIFESTYLE AND ENTERTAINMENT INC.,
PRESIDENT MR. EDGAR C. TEJERERO REGARDING FREE MOVIE WATCH
OF SENIOR CITIZENS IN THE MUNICIPALITY OF TAYTAY, RIZAL**

WHEREAS, the Senior Citizens of this Municipality presently avails free movie watch at SM CITY TAYTAY as their additional privilege and benefit base on Resolution No. 85 series of 2008 amended by Resolution No. 126 series of 2014;

WHEREAS, the said Resolution was supported by Resolution No. 26 series of 2013, authorizing the former Mayor Janet DL. Mercado to enter into a Memorandum of Agreement with SM City Taytay and ratified by Resolution No. 125 series of 2014;

WHEREAS, the Memorandum of Agreement will will expire on April 8, 2017 by which the Senior Citizen free movie watch will be affected;

WHEREAS, for the continuity of the free movie watch of Senior Citizens of Taytay, there is a need to authorize the Municipal Mayor to negotiate and enter into Memorandum of Agreement with SM City Taytay;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 10th Sangguniang Bayan of Taytay, Rizal duly assembled in session, hereby authorizes the Honorable Mayor George Ricardo R. Gacula II to negotiate and enter into a Memorandum of Agreement with SM Prime Holdings Inc. represented by SM Lifestyle and Entertainment Inc., President Mr. Edgar C. Tejerero regarding free movie watch of Senior Citizens in the Municipality of Taytay, Rizal;

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned, and that the Memorandum of Agreement shall be ratify first by the Sangguniang Bayan before its full implementation.
