**A RESOLUTION EXTENDING THE 2016 ACCREDITATION OF CIVIL
SOCIETY ORGANIZATIONS FOR THE SELECTION OF REPRESENTATIVES
TO THE LOCAL SPECIAL BODIES UNTIL 5:00 PM SEPTEMBER 7, 2016**

WHEREAS, the DILG Memorandum Circular 2016-097 IV.3.b states that “The Sanggunian shall issue, before but not later than the last working day of August the following:

- a). Certificate of Accreditation of every qualified CSO
- b). Notice to every organization who did not apply, encouraging them to apply for accreditation

WHEREAS, the Schedule for Selection of Representatives to the LSB set on September 5-16, 2016. The Municipal Local Government Operations Officer (MLGOO). Engr. Jennylyne P. Alvarez advised that the Sangguniang Bayan may extend the accreditation period to give adequate time to CSO's that have yet to complete their requirements until before the convening and selection of Representatives to the LSB's;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 10th Sangguniang Bayan of Taytay, Rizal duly assembled in session hereby extending the 2016 accreditation of civil society organization for the selection of representatives to the local special bodies until 5:00 P.M. of September 7, 2016;

RESOLVED FURTHER, that due to the adjustment on the deadline for Accreditation, the remaining days for the Selection of Representatives to LSB, specifically between September 9 to 16, shall be the prescribed schedules for the convening and selection for the LSB of Taytay, Rizal;

RESOLVED FURTHERMORE, that No further extension shall be set pertaining to the 2016 Accreditation of Representatives to the LSB;

RESOLVED FINALLY, that the copies of this resolution be furnished to all concerned for their inform and appropriate action;
