**AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO TRANSACT,
NEGOTIATE AND SIGN DOCUMENTS RELATIVE TO THE LAND
ACQUISITION OF OPEN SPACE, ROAD LOTS ALLEYS AND PATH WALKS
AT SITIO BAYABAS AND SITIO TAGUMPAY BARANGAY SAN ISIDRO,
TAYTAY, RIZAL**

WHEREAS, on March 25, 2014, Sangguniang Bayan has passed Resolution No. 118 series of 2014 giving authority to the former Local Chief Executive for the land acquisition of open space, road lots alleys and path walks at Barangay San Isidro, Taytay, Rizal;

WHEREAS, pursuant to section 444 of R.A. 7160 also known as Local Government Code of 1991 (a) the Municipal Mayor as the Chief Executive of the Municipal Government shall exercise such powers and perform duties and functions as provided by this code and other laws;

WHEREAS, various resolution from the Sitio Bayabas and Sitio Tagumpay respectively rendered their intension and willingness to purchase the land to Mr. Bartolome Rivera, Jr.;

WHEREAS, Mr. Bartolome Rivera, Jr., had responded to the intensions of the residents of Sitio Bayabas and Sitio Tagumpay and expressed his intension to sell the subject lots;

WHEREAS, the residents of Sitio Bayabas and Sitio Tagumpay cannot afford to purchase road lots and open space within the property of Mr. Bartolome Rivera, Jr.;

WHEREAS, beneficiaries of the subject lot signifies their intention to purchase the lots through direct buying scheme with terms and conditions;

WHEREAS, the Sangguniang Bayan shall ratify the said Memorandum of Agreement before its full implementation;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Taytay, Rizal duly assembled in session hereby amends Resolution No. 118 series of 2014 to be read as “Authorizing the Local Chief Executive to transact, negotiate and sign documents relative to the land acquisition of open space, road lots alleys and path walks at Sitio Bayabas and Sitio Tagumpay, Barangay San Isidro, Taytay , Rizal”.

RESOLVED FURTHER, that the copies of this resolution be furnished to all concerned for their information and appropriate action.
