**A RESOLUTION APPROVING THE REHABILITATION/
EXPANSION OF RHU 5B, (ARENDA) TAYTAY, RIZAL UNDER
THE PROGRAM OF THE DEPARTMENT OF HEALTH (DOH)
REGION IV-A CALABARZON “HEALTH FACILITIES ENHANCEMENT
PROGRAM FUND”**

WHEREAS, The General Welfare Clause of R.A. 7160, otherwise known as the Local Government Code of 1991, provides;

Section 16. General Welfare - every local government unit shall exercise the powers expressly granted those necessarily implied there from, appropriate or incidental for its efficient and effective governance, and those which are essential to the general welfare;

WHEREAS, this municipality through the support and help of DOH have been recently granted eight (8) new RHU facilities located in five (5) different barangays including the said area, designed to accommodate the three added services namely: Animal Bite Treatment Center, Laboratory and Dental Services;

WHEREAS, for the implementation of this project a resolution is needed as one of the requirement by the Department of Health;

WHEREAS, through this, more Rural Health Unit (RHU) and facilities, more health care can be provided to protect and promote the right of the people and instill health consciousness as stated on Article II Declaration of State Principles and Policies, Section 15 of the Philippine Constitution;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved to adopt a Resolution approving the rehabilitation/expansion of RHU 5B, (Arenda) Taytay, Rizal under the program of the Department of Health (DOH) Region IV-A CALABARZON “Health Facilities Enhancement Program Fund”.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action.
