SCHOOL, THE BAGONG PAG-ASA ELEMENTARY SCHOOL**

WHEREAS, Article XVI, Section 1 of the Philippine Constitution implies that the state shall protect & promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all;

WHEREAS, to provide better quality education for the approximately 1,123 pupils of Bagong Pag-Asa Elementary School Annex, it is necessary to separate it from its mother school to address the needs of its increasing number of pupils;

WHEREAS, based on DepEd Order No. 40 series of 2014, a proposed separation of the school annex must be supported by the Local Government Unit;

NOW THEREFORE BE IT RESOLVED, as it is hereby resolved by the 10th Sangguniang Bayan of Taytay in a session duly assembled, hereby supports the separation of Bagong Pag-Asa Elementary – Annex from its mother school, the Bagong Pag-Asa Elementary School.
