**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE OF
TAYTAY RIZAL TO RENEW OR RENEGOTIATE THE CONTRACT OF
LEASE WITH CRUZCON FOR THE OPERATION OF A MUNICIPAL
TIANGGE**

WHEREAS, there is a need to step up the promotion of Taytay as the Garment Capital of the Philippines;

WHEREAS, the present Municipal Tiangge is presently located in the property of J.S. Cruz Construction and Development (CRUZCON) Inc.;

WHEREAS, the Contract of Lease between CRUZCON and the Municipal Government of Taytay need to be renewed with such terms and conditions to be mutually agreed upon by the parties;

NOW THEREFORE, be it resolved, as it is hereby resolved by the 10th Sangguniang Bayan of Taytay, Rizal duly assembled in session hereby authorizes the Local Chief Executive to negotiate for the renewal of the Contract of Lease with CRUZCON under such terms and conditions for the operation of a Municipal Tiangge;

RESOLVED FURTHER, that the Contract of Lease with CRUZCON for this purpose should be ratified by the Sangguniang Bayan first before its full implementation;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned parties for their information and appropriate action;
