GACULA II TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF  
AGREEMENT WITH NATIONAL FOOD AUTHORITY (NFA) REPRESENTED  
BY ITS PROVINCIAL MANAGER ARMANDO RAY C. VILLACORTA TO  
PURCHASE RICE ON CREDIT FOR ITS RELIEF OPERATION  
WHENEVER A STATE OF CALAMITY IS DECLARED**

WHEREAS, NFA is the government agency in-charge with, among others ensuring the nation's with adequate supply and distribution of grain;

WHEREAS, under the Local Government Code (LGC), local government units are vested with authority to discharges the function and responsibilities of national agencies and offices devolved to them;

WHEREAS, provinces, cities, municipalities in particular have been tasked with providing basic social services including relief assistance in time of calamities;

NOW THEREFORE BE IT RESOLVED, as it is hereby resolved by 10<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in a session duly assembled hereby Authorizes Municipal Mayor Hon. George Ricardo R. Gacula II to Negotiate and Enter into a Memorandum of Agreement with National Food Authority (NFA) Represented by its Provincial Manager Armando Ray C. Villacorta to purchase Rice on credit for its relief operation whenever a state of calamity is declared.

RESOLVED FURTHER that the Memorandum of Agreement shall be ratified by the Sangguniang Bayan;

RESOLVED FURTHERMORE, that copies of this resolution be furnished to all concerned for their information and appropriate action.
