**GRANTING THE AUTHORITY TO THE LOCAL CHIEF EXECUTIVE TO
ENTER INTO AND SIGN MEMORANDUM OF AGREEMENT (MOA) FOR
AND IN BEHALF OF THE MUNICIPALITY OF TAYTAY, RIZAL FOR THE
IMPLEMENTATION OF PROJECTS, PROGRAMS AND ACTIVITIES (PPAs)
FROM VARIOUS NATIONAL GOVERNMENT AGENCIES AND OTHER
FUNDING AGENCIES TO THE MUNICIPALITY**

WHEREAS, National Government Agencies (NGAs) and other funding agencies from time to time tap Local Government Units to implement their projects and programs to reach the grassroots level;

WHEREAS, before the implementation of these programs, projects and activities a Memorandum of Agreement is needed to be executive between the National Government Agencies (NGAs) and the Local Government Unit;

WHEREAS, there is a need to consolidate synchronized the action of all stakeholders to avoid delay in the implementation of a vital projects, such as livelihood, flood control program and other programs and activities that would reduce poverty incidence in all identified areas of this Municipality;

WHEREAS, Hon. GEORGE RICARDO R. GACULA II, Municipal Mayor, in his endorsement letter, has requested the Sangguniang Bayan for authority to enter into and sign MOAs for his purpose;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Taytay, Rizal in session duly assembled, hereby Grants Authority to Hon. GEORGE RICARDO R. GACULA II, Municipal Mayor to enter into and sign Memorandum of Agreement (MOA) for and in behalf of the Municipality of Taytay, Rizal for the implementation of Projects, Programs and Activities (PPAs) from various National Government Agencies and other funding agencies to the municipality;

RESOLVED FURTHER, that the Sangguniang Bayan shall be directly informed in writing beforehand of the project and activity to be funded by National Government Agencies (NGAs) and other funding agencies before the implementation;

RESOLVED FURTHER, that the said MOA shall be ratified first by the Sangguniang Bayan before its full implementation;

RESOLVED FURTHER, that the Sangguniang Bayan shall be furnished with copy of the duly signed MOA executed between the Implementing Agency (NGAs and other funding agencies) and the Municipality of Taytay;

RESOLVED FURTHERMORE, that a copy of this Resolution be forwarded to the Hon. George Ricardo R. Gacula II for his information and appropriate executive action;

ADOPTED, this 15th day of August, 2016 at the Session Hall of the Municipal Building of Taytay, Rizal.
