**A RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF TAYTAY
REPRESENTED BY HON. GEORGE RICARDO R. GACULA II, MUNICIPAL MAYOR
TO ENTER INTO A MEMORANDUM OF AGREEMENT BETWEEN THE BUREAU
OF FIRE PROTECTION (BFP) REPRESENTED BY CSUPT. RODRIGO A.
ABRAZALDO, DSC, BFP, OFFICER IN CHARGE BFP/DEPUTY CHIEF FOR
ADMINISTRATION TO RELEASE THE TWENTY PERCENT (20%) SHARE IN THE
FIRE CODE REVENUES**

WHEREAS, the Bureau of Fire Protection is an attached agency of the Department of Interior and Local Government;

WHEREAS, Bureau of Fire Protection (BFP), through DOF-DBM-DILG Joint Circular No. 2015-01 dated 12 February 2015 is hereby authorized to release the twenty percent (20%) share in the Fire Code Revenues top concerned municipalities upon release of Special Allotment Release Order (SARO) / Notice of Cash Allocation (NCA) from the Department of Budget and

Management (DBM) for collection for CY 2010,2011,2012 and 2013 CY 2014 to 2015 collection will be directly released by the DBM to the Municipality;

WHEREAS, Municipal Government of Taytay, Rizal shall appropriate the twenty percent (20%) share exclusively for the improvement and maintenance of the Municipal BFP Fire Stations to include acquisition of firefighting equipment, service vehicles, investigative equipment, rescue equipment, office equipment, office furniture & fixtures and construction / repair of Municipal BFP fire station;

WHEREAS, Bureau of Fire Protection and Municipal Government of Taytay, Rizal shall ensure the effective collection of Fire Code Revenues and its efficient allocation for the improvement of municipal BFP Fire stations;

WHEREAS, the said Memorandum of Agreement shall have to be ratified first by the Sangguniang Bayan of Taytay before its full implementation;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Taytay, Rizal duly assembled in session hereby authorizes the Municipal Government of Taytay represented by Hon. George Ricardo R. Gacula II, Municipal Mayor to enter into a Memorandum of Agreement between the Bureau of Fire Protection (BFP) represented by C Supt. Rodrigo A. Abrazaldo, DSC, BFP, Officer in Charge BFP/Deputy Chief for Administration to release the Twenty Percent (20%) share in the Fire Code Revenues;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action;

ADOPTED, this 15th day of August, 2016 at the Session Hall of the Municipal Building of Taytay, Rizal.
