**APPROVING SUPPLEMENTAL BUDGET NO. 1 “ AN ORDINANCE
APPROPRIATING THE AMOUNT OF NINE MILION EIGHT HUNDRED
THIRTY SIX THOUSAND FOUR HUNDRED FIFTY THREE PESOS AND
FORTY NINE CENTAVOS (PHP9,836,453.39) FROM THE 20%
DEVELOPMENT FUND UN-APPROPRIATED BALANCE-RETAINED
EARNING FY 2014 (SURPLUS) TO SOLID WASTE MANAGEMENT
PROGRAM, THIS MUNICIPALITY**

WHEREAS, Municipal Development Council (MDC) Resolution No. 2015-005
“Resolution Appropriating the amount of Nine Million Eight Hundred Thirty Six Thousand Four
Hundred Fifty Three Pesos and Forty Nine Centavos (Php9,836,453.49) from the 20%
Development Fund Un-Appropriated Balance-Retained Earning FY 2014 (SURPLUS) to Solid
Waste Management Program was adopted and ratified by this Honorable August Body;

WHEREAS, there is a need for a supplemental budget in order to appropriate the un-
appropriated balance-retained earning FY 2014 (SURPLUS) under the 20% Development Fund,
this Municipality;

NOW THEREFORE, the Sangguniang Bayan of Taytay, Rizal in session duly assembled hereby decrees;

SECTION 1. That the Appropriation to wit;

SECTION 4. That the same rules and procedures with that of the FY 2015 Annual Budget shall apply in the implementation of this appropriation ordinance;

SECTION 5. That this Ordinance shall take effect upon its approval;
